### Judges Cup Update

1. Nov. 17-18, 2018 at Roswell Gymnastics - Helena will coordinate volunteers
2. NAWGJ Membership will be reimbursed for all who volunteer minimum required sessions
3. Specific requests for hospitality needs will be sent when we have an idea of the meet size and needs

### Booking

4. Aug. 18, 2018 in coordination with testing
5. Booking order will be based on the following protocol per USAG
  - a. Current ratings are valid through Dec. 31, 2018; however, assignors are using the following priority list in assigning meets in the fall:
  - b. First assign those who have tested and passed and have a rating valid 2018-22
  - c. 2<sup>nd</sup>: Those who have tested and passed one part
  - d. 3<sup>rd</sup>: Those who have tested but have not passed ether part
  - e. 4<sup>th</sup>: Those who have not yet tested..only if absolutely necessary.
6. Gwyned will be sending out Hard To Book meets soon.
7. Fall State Meet - Upon approval from GA USAG State Committee - Because of the smaller fall season, judges assigned to the meet will be allowed to choose 3 meets prior to booking. Judges' Cup will fulfill one of the meets if you judge (you must let Helena know in advance). The regular booking order will then begin.

11. Safe Sport Update regarding minor judges
    - a. Minor judges will not be allowed to ride or room with another judge (unless it is their parent). Meet directors will be required to pay for travel of a minor judge accompanied by a parent (Mileage and Overnight Accommodations).

### Meet Referee Fines

13. Effective this season, meet referees will be fined for failing to record sanction violations on the sanction form.

- a. Fines will start at \$100 and will probably increase for repetitive infractions
